BY-LAW NUMBER 2022-XX

A by-law to amend the Town of Oakville's Zoning Bylaw 2014-014, as amended, to permit the construction of a mixed use building on lands described as 207, 217 and 227 Cross Avenue and 571, 581 and 587-595 Argus Road (File XXXX)

COUNCIL ENACTS AS FOLLOWS:

- 1. That Schedule "19(8b)" to By-law 2014-014, as amended, is hereby further amended by rezoning lands municipally described as 207, 217 and 227 Cross Avenue and 571, 581 and 587-595 Argus Road in the Town of Oakville, Regional Municipality of Halton from the "MTC" and "MTE" to the "MU4 (XXX)" Zone as identified on Schedule A attached hereto.
- 2. Section 15, Special Provisions, of By-law 2014-014, as amended, is amended by adding new Sections 15.XX.1, 15.XX.2, 15.XX.3 and 15.XX.4 with respect to the lands municipally known as 207, 217 and 227 Cross Avenue and 571, 581 and 587-595 Argus Road:



b)	Minimum number of <i>parking spaces</i> for residential visitor and Retail and Office use	410 spaces				
c)	Visitor parking for residential uses may be counted towards required parking for retail and office uses.					
	15.XX.4 Special Site Provision					
a)	Notwithstanding any severance, partition or division of the lands subject to this Special Provision, all lands subject to this by-law shall be considered to be one <i>lot</i> for the purposes of this By-law.


